

For the ABE annual application submitted in 2022, all consortia will submit a Table A (contact hours from May 2021-April 2022) and again Table A1 (March 2019-March 2020).

Consortium contact hours for FY23 ABE funding will be determined either by using Table A or reusing Table A1, whichever has a higher number of contact hours.

This recommendation was endorsed by the Literacy Action Network. MDE Adult Education, Finance, Government Relations, and the Executive Teams have reviewed the recommendation. It has been approved!

### **2022 State WIOA Plan Revision Tentative Timeline**



- December 14, 2021: U.S. Department of Labor releases WIOA State Plan revision guidance.
- January 3, 2022: State agencies meet to discuss WIOA state plan revision process.
- By February 1, 2022: All state agencies must submit their proposed revisions to DEED.
- Early February-Early March 2022: Revised WIOA State Plan posted for public comment.
- March 15, 2022: DEED must submit the revised plan to the federal government

#### Minnesota State WIOA Plan

• Adult Education specific section (pp.225-253)

#### **Potential Proposed Revisions**

- Reduce duplicated information.
- Extend federal competition to once every 6 years (or federal reauthorization), instead of once every 5 years.
- Slightly revise federal funding formula to allow MDE to incentivize IET programming and to fund statewide online career pathway classes for providers approved for federal funding.
- Articulate system innovations in equity, technology and other areas




### **Afghan Evacuee Update - Employment and Training**
